## 1. What have we achieved?

#### 1. Awareness, partnership and fundraising:

- Good national media coverage; Some international awareness (e.g. Mavrovo dam projects)
- National: [GOs, NGOs, interest groups]; international: ...
- Fundraising: MAVA Foundation, SCOPES (SNF), Norway, others...

### 2. Balkan lynx biology and ecology:

- Baseline survey MK, AL: distribution, trends, threats, attitudes
- Camera trapping Mavrovo (density); AL, MK (presence)
- Two male lynx radio-collared in Mavrovo

#### 3. Protected area establishment:

- Proclamation of Shebenik-Jabllanica NP (AL) 2008
- Proclamation of Korab-Koritnik Nature Park (AL) 2011

### 4. Planning and implementation conservation actions:

- Balkan lynx recovery strategy (AL, MK → Bern Convention=
- National Action Plans AL, MK
- Monitoring and Networks





### 2. Where have we failed?

### 1. Awareness, partnership and fundraising:

- Awareness for Balkan lynx, but not for "conservation environment" (habitat, development, prey, wildlife management)
- No reliable commitment of state institutions
- Narrow funding base and no long-term funding secured

### 2. Balkan lynx biology and ecology:

- No significant radio-telemetry sample, lack of important biological/ecological information
- No detection of functional population outside Mavrovo (does it exist?)

#### 3. Protected area establishment:

- No establishment of new PAs in Macedonia
- Lack of capacity and administrative bodies, no consistent management

### 4. Planning and implementation conservation actions:

- No agreement AL–MK
- Very limited support for development and none for implementation of NAPs





# 3. What are the challenges ahead?

### 1. Awareness, partnership and fundraising:

- 1. Improve outreach at national/international level
- 2. Partnership with national GOs/NGOs, interest groups (e.g. hunters) and int. org.
- 3. Secure long-term funding (national: monitoring, international: conservation)

## 2. Balkan lynx biology and ecology:

- 1. Complete baseline surveys in northern areas (Montenegro, Kosovo)
- 2. Advance ecological (radio-telemetry) and genetic research on lynx
- 3. Improve knowledge on prey population

#### 3. Protected area establishment:

- 1. Secure support of local communities for PAs within Green Belt
- 2. Implement models for sustainable use/management of natural ressouces in PAs
- 3. Continue lobbying/secure support of GOs and European institutions

### 4. Planning and implementation conservation actions:

- 1. Secure national commitment through multi-lateral agreement under int. facilitation (Bern Convention, EU (HabDir), IUCN)
- 2. Include sustainable wildlife management into Balkan lynx conservation planning
- 3. Include entire area (present, future distribution) into conservation Strategy
- 4. Update/develop and implement National Action Plans
