

\* The ornithological site of Ezerani at the Prespa Lake was recognized by a 1996 law as the "Ezerani" strict national reserve with a surface area of 2080 ha.

By a 1997 law, the ornithological site of Tikves in the Crna River canyon was recognized as the "Tikves" strict national reserve, with a surface area of 10.650 ha.

\*\* The [Ohrid Lake](#) and its coast and the cultural sites in the town of Ohrid were registered in 1980 in the UNESCO's A List (according to the criteria of the Paris Convention for the Protection of the International Cultural and Natural Heritage).

The Prespa Lake, together with its coast (areas let under water) was entered to the Ramsar A List in 1995 as a wetland (Ramsar site) of international importance for waterbird protection (according to the Ramsar Convention criteria).
